
To install and maintain approximately 1,400 feet, more or less of 4 inch gas main in Blanchard Boulevard, Braintree. From the existing 2 inch gas main in Blanchard Boulevard at House #116 Southeasterly to the existing 4 inch gas main in Elm Street. All of which to replace and abandon the existing 2 inch gas mains in Blanchard Boulevard, Braintree.

Petition #10 030 was unanimously approved by Council with the following conditions:

DPW: Blanchard Boulevard is not covered under any moratorium. It is our recommendation that this petition **should be approved with our "standard" repair specifications.**

4-116 Blanchard Boulevard, Braintree MA

As part of the 2010 ACE 107 BSCSWI Program Asset Replacement, recommends the relay of approx. 1400 feet of 2 inch, 60 psig bare steel (1941) with 4 inch plastic from the exist 2 inch plastic in Elm St to the exist 2 inch coated steel at #116.
