### PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS

The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

**To install and maintain approximately 675 feet, more or less of 2 inch gas main at Edgemont Road, Braintree. From the existing 2 inch gas main at Quincy Avenue Westerly to the existing 2 inch gas main at House #57. All of which to replace and abandon the existing 2 inch gas main in Edgemont Road, Braintree.**

**Petition #12 019 was unanimously approved by Council with the following conditions:**

**DPW: Edgemont Road has not been resurfaced recently and is not on the short list for improvement. It is our recommendation that this petition should be approved with our "standard" repair specifications, with a final pavement being maintained flush with the surrounding pavement immediately (do not leave the trench down.)**



PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS


Town of Braintree/ Town Council:-

ORDER FOR GAS MAIN LOCATION


Town of Braintree/ Town Council:
