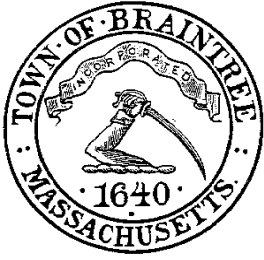

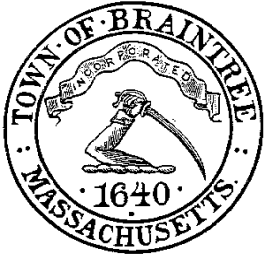

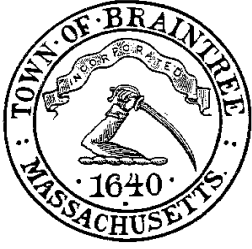

A meeting of the Committee on Education and Library was held in Fletcher Hall, Braintree Town Hall, on Tuesday, March 9, 2016 at 6:00p.m.

Chairwoman Hume was in the Chair and conducted the roll call.

Chairwoman Hume stated the purpose for meeting tonight was to discuss issues and possibly meet on them in the future. I just wanted to get the information out there.

Chairwoman Hume welcomed Superintendent Frank Hackett and Lisa Heger of the School Committee to give an overview on what the School Department is doing.

Lisa Heger stated sub-committees of the School Committee have been re-organized. A new committee this year is the Policy Committee. We will review and update and establish policies that we do not have. We are discussing search and seizure policy and also flexible boundaries and where we might have to move kids in town due to schools having too many kids in them.

Councilor Owens asked what do you mean by flexible boundaries?

Frank Hackett, Superintendent stated right now we have fixed boundaries. There is no flexibility on where you will go to school when you move into a certain neighborhood. Our enrollment has increased particularly around Liberty School being one of them which is the smallest school. What we would be looking to do is for students moving into town who are new with no siblings they might fall into the flexible boundary. There will be areas that are fixed due to the way the buses run. It helps control and better manage the numbers.

Chairwoman Hume asked if there is a need for something for Liberty this fall. Are you looking at modular? Is it something you can fix within the building?

Frank Hackett, Superintendent stated yes but no more than it is currently. Liberty would look the same next year as it did this year. It is very tight. We would benefit from additional space there now. A portable unit which is not modular would cost about \$200,000. It is not the best way to spend money. I have met with the staff and they are frustrated. They are looking for some more immediate relief. We do not have a lot of options.

Lisa Heger listed sub-committees of the School Committee: Collective Bargaining, Policy, Budget, Legislative Liaison, BASHY, SEPAC, Petersen Pool Sports Complex. There is also a task force on Substance Abuse lead by Dave Ringius. Frank Hackett stated we are trying to identify staffing for wellness to the middle school and hit the kids with wellness to deliver curriculum on those topics.

Chairwoman Hume stated this has been presented to us as a Council and we will be working on that also but it falls in your hands – you the School Department.

Frank Hackett stated yes it does. I know everybody wants more and we need more but I do not want to be working under the assumption that there's been nothing. The biggest first step is to map out what we are doing in the broad health and wellness not just opioid but prevention. Kids who do not feel good about themselves don't do drugs. Our second step program and bullying prevention, after school program and how do we connect kids to school are all the first steps.

Chairwoman Hume asked that all to be put together and send it to the Council. Council now has their own Opioid committee and it would be helpful if everyone is sharing information.

Councilor Owens stated this partnership has been suspended until it completes the restructuring.

There was no leadership to guide that through. There will be a relaunch of the new partnership. We need to coordinate all together or not be that effective. We need to address the issue of awareness.

Frank Hackett stated there are a lot of people working really hard. We have an obligation to coordinate with what the town is doing. I hope we take steps in unison. I will do everything if the funding is available.

Frank Hackett stated we will be working to revise goals and objectives over the next few months.

Councilor Owens asked what is going on with the technology?

Frank Hackett stated the amount of work over this past year has been tremendous to completely rewire every school. We are almost one to one with students and devices meaning at any point during the day a student can access a device. It has been tough getting a Technology Director. Job posting went out twice. We want someone with teaching and learning and technology background. We essentially split the position.

Chairwoman Hume stated we do have a copy of the Draft Budget but this will be discussed at the Ways & Means and this could change before the Budget meetings.

Chairwoman Hume stated East project is going forward.

Frank Hackett stated there still needs to be a lot of discussion about this. We will form advisory committees with parents, teachers, guidance counselors, etc. We will ask if spaces are located correctly to bring grade 5 up.

Chairwoman Hume stated there will be a tour of Liberty during the day to see the daily movement.

Lisa Heger stated when Councilors show up to schools it speaks volumes.

Chairwoman Hume stated the Library Strategic Plan is on Saturday, March 19th in Logan Auditorium.

Chairwoman Hume stated Kristen Zechello, ADA Coordinator for the Commission on Disabilities toured all schools except Flaherty and will identify areas where they are not in compliance. There will be a report on this.

It was unanimously voted to adjourn the meeting at 6:48p.m.

Maintenance Department Recommendation

Honorable Mayor Charles Kokoros,

Braintree District 4 Town Councilor Stephen O'Brien would like to invoke the following Charter Legislation and calls for consolidation of the Municipal Maintenance Department under one department:

4-5.3. Charter allows for the Town Council to establish a central municipal maintenance department

The school committee shall provide ordinary maintenance of all school buildings and grounds, but the town council may, by ordinance, provide for the establishment of a central municipal maintenance department which may, subject to the approval of the school committee, include maintenance of school buildings and grounds.

This change would require modification to both your budget and specifically the Braintree Schools budget. As per Dr. Hackett, Braintree Public Schools back in 1972 budgeted 28 Maintenance staff and a separate number of 88 Custodians. Since that time, while there has been a reduction in building use, Braintree Schools and the School Committee have degraded that department to 6 Maintenance staff and 39 Custodians (FY2020). This may explain why some school buildings have, in the eyes of residents and teachers, degraded.

Maintenance under one department for Municipal buildings with a dedicated leader and a team approach has already provided cost savings and benefits to the Town of Braintree.

Working with our Town's Internal Auditor, we have identified maintenance line items across various departments' budgets. Consolidation to one central department is the recommendation and makes absolute sense given the needs of the Town, I know you will do the right thing and consolidate beyond what is recommended here.

I formally request the Chief Of Staff work with our Town Solicitor to craft the necessary "ordinance" as needed while this is being considered by the Town Council for action.

This move makes sense and should occur in the FY2022 budget year.
