**MINUTES:**

**Motion By:** Dr. Nedelman approve the meeting minutes of June 18, 2015.

**OLD BUSINESS:**

**1) Review of proposed draft (#2) Body Work Regulation**

Ms. McGrath advised the Board that she has been working with Police Chief Jenkins on specific language in the draft regarding background checks in sections 5.0 (k) and 6.0 (g), and the keeping of a log book in section 9.0 (5) of the draft regulation. The draft has been completed for their review and approval to move the regulation forward to the Town Solicitor for review.

The Board endorsed the changes in draft # 2 and asked Ms. McGrath to forward the draft regulation to the Town Solicitor for review as to legal form.

**NEW BUSINESS:**

**2) Review of proposed amended School Tobacco and Nicotine Delivery Products Usage regulation.**

Ms. McGrath advised the Board that a draft regulation is being brought before them this evening to update the current School Tobacco Use Regulation to incorporate the newer products, such as nicotine delivery products, blunt wraps, etc. Mrs. Dowd and members of the school department asked that the current regulation be updated.

Mrs. Dowd advised that the problem that the schools have been having is the use of electronic cigarettes on school property.

Ms. McGrath advised that the draft regulation before them this evening does not include the recommendations by D.J. Wilson, with the MA Tobacco Control Program because she just received his email the evening prior to the meeting and the packets had already been distributed to the Board.

Ms. McGrath reviewed each recommendation provided by Mr. Wilson with the Board for their review and consideration.

**Motion By:** Mrs. Dowd to incorporate the items recommended by Mr. Wilson, with the MA Tobacco Control Program and to then send the draft regulation to the Town Solicitor for review.
