PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS

The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 475 feet, more or less of 2 inch gas main in Beechwood Road, Braintree.

From the existing 2 inch gas main in Beechwood road @ Argyle road Northeasterly to No. 117 Beechwood Road. All of which to replace and abandon the existing 2 inch gas main in Beechwood Road, Braintree

Petition #09-029 was unanimously approved by Council with the following conditions:

09-029 – **Beechwood Road** in that area is in pretty good condition, and will be recommended to be on the next road project for a preservation treatment, so this replacement **may be approved with our "standard" repair specifications.**


To install and maintain approximately 475 feet, more or less of 2 inch gas main in ~~Massachusetts Avenue~~, Braintree.

ORDER FOR GAS MAIN LOCATION


Town of Braintree / Board of Selectmen:
