REQUEST OF: NATIONAL GRID

National Grid hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 145 feet of 2 inch gas main in Ellis Ln, from the existing 2- inch main at house #55 Sheppard Ave to the westerly end of main near house #10 Ellis Ln all in order to replace and abandon the existing gas main in Ellis Ln.

BELD: No underground electric utility conflicts or special requirements within the proposed scope of work.

DPW: Ellis Ln is not under a moratorium on road openings and is scheduled to have its water lines replaced this year. We recommend approval under the standard conditions and that the approval be further conditioned upon the petitioner 1.) expediting the work on Ellis Ln and Sheppard Av as the Town will be replacing the water lines there this season; 2.) laying the gas main outside of the trench of the water and sewer mains in service; 3.) not leaving the trench pavement low for any length of time; and 4.) repairing or replacing curbs and sidewalk areas disturbed each to the satisfaction of the Highway Superintendent. We also recommend that the following requirement be added to the permit, if granted:

Neither National Grid nor any of its contractors is authorized to close any street or to close a direction of travel to facilitate their work without authorization from the Director of the Department of Public Works or the Highway Superintendent. The Chief of Police can also authorize a closure for a police or fire emergency. Construction zone traffic safety issues are to be addressed by using appropriate traffic control signs and devices and the use of police officers for traffic control to safely guide traffic through the work zone. If a closure is authorized by the DPW, it shall not be implemented until signs and police officers (where needed) are properly in place in conformity with the written plan prepared by the contractor's engineer and approved by the DPW and Police Department.



The Nationalgrid hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways and places of the **Town of Braintree** and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 145 feet more or less of 2 inch gas main in Ellis Ln., Braintree, from the existing 2 inch gas main at house #84 Sheppard Ave. westerly to the end of main at house #10 Ellis Ln. All of which to replace and abandon the existing gas main in Ellis Ln.
