#### Mission Statement

The Braintree Police Department recognizes the continuous threats made to the safety, security and tranquility to our Country, State, Community and Citizens alike. We will work with other Local, State and Federal agencies to enhance our intelligence in an effort to protect the public to the best of our abilities while ensuring the continued protection of individual privacy, civil rights, civil liberties and other interests.

#### Liaison Officer 46.3.1

The Chief shall appoint an Intelligence Liaison Officer (ILO), who shall act as the Department liaison in the exchange of information of a terrorist nature and other matters of public concern. **[46.3.1]**

The liaison may gain knowledge through information sharing, in meeting and electronic form, with private, state and federal agencies. This would include, but not be limited to, the following agencies; **[46.3.1]**

**Anti-Terrorism Advisory Council (ATAC)**  
**Commonwealth Fusion Center (CFC)**  
**Boston Regional Intelligence Center (BRIC)**  
**New England State Police Network Center (NESPIN)**  
**Public Utility Companies (Electric, Gas, Propane etc.)**

Department Reporting and Dissemination of Information 46.3.2

Terrorism related information received by the Department shall be documented. The Shift Commander shall review the incident report. A copy of which will be forwarded to the Intelligence Liaison Officer (ILO), who will fax it to the Commonwealth Fusion Center. The Shift Commander may contact the ILO for immediate assistance. **[46.3.2]** Information will be disseminated at roll call and through sworn personnel email. Is maintained and stored by the ILO in an electronic file. The ILO will be the point of contact for the FBI Boston's Joint Terrorism Task Force.
