National Grid hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 45 feet, more or less of 2 inch gas main in Hickory Road, Braintree.

From the existing 2 inch gas main at House #33, Westerly to House #38 for a new gas service.

Approval is conditioned with final pavement being maintained flush with the surrounding pavement immediately (do not leave the trench down.)

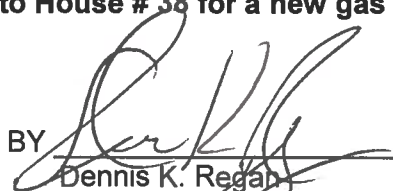

Town of Braintree/ Town Council:

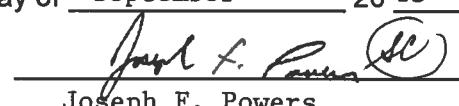
