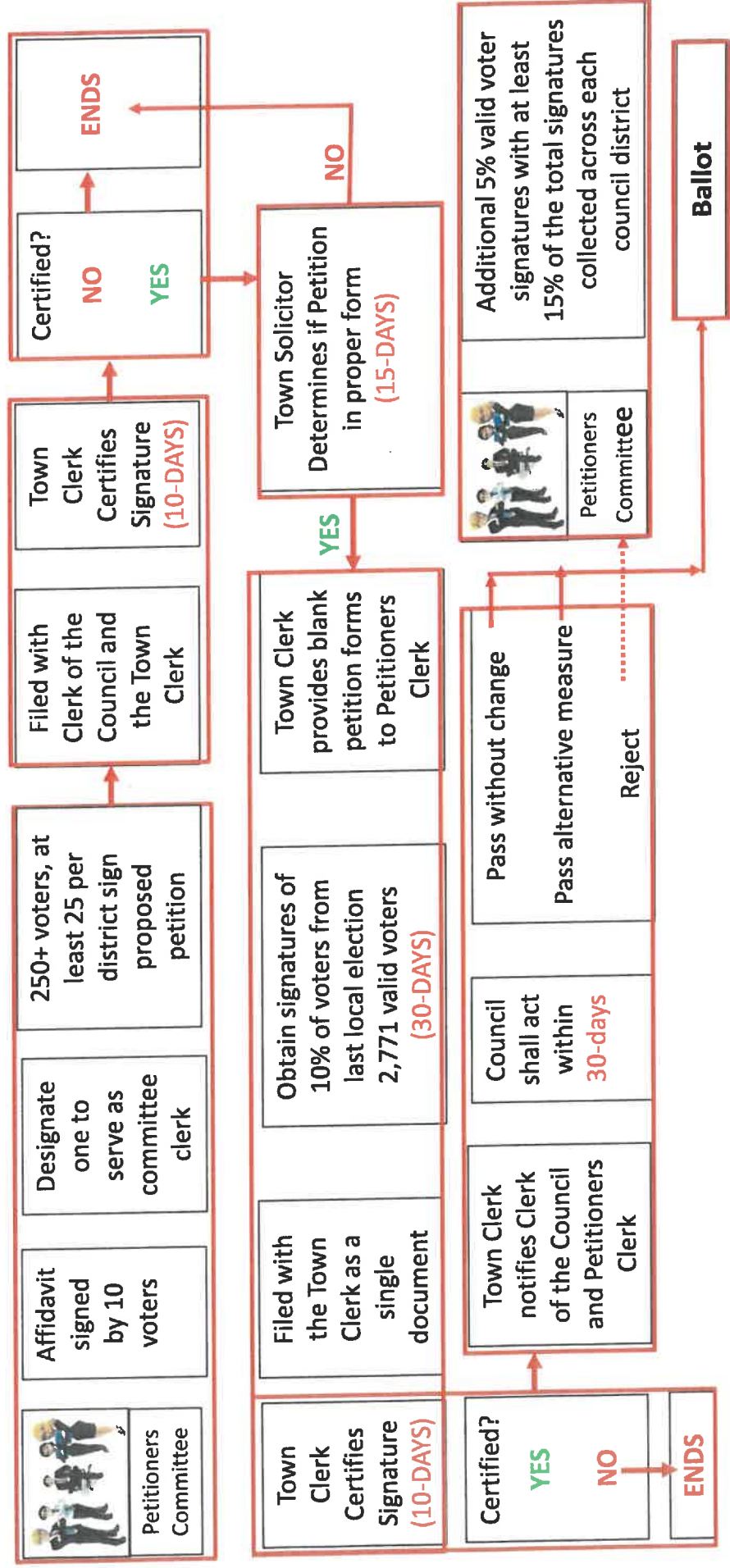

Section 7-10 Submission of other matters to voters

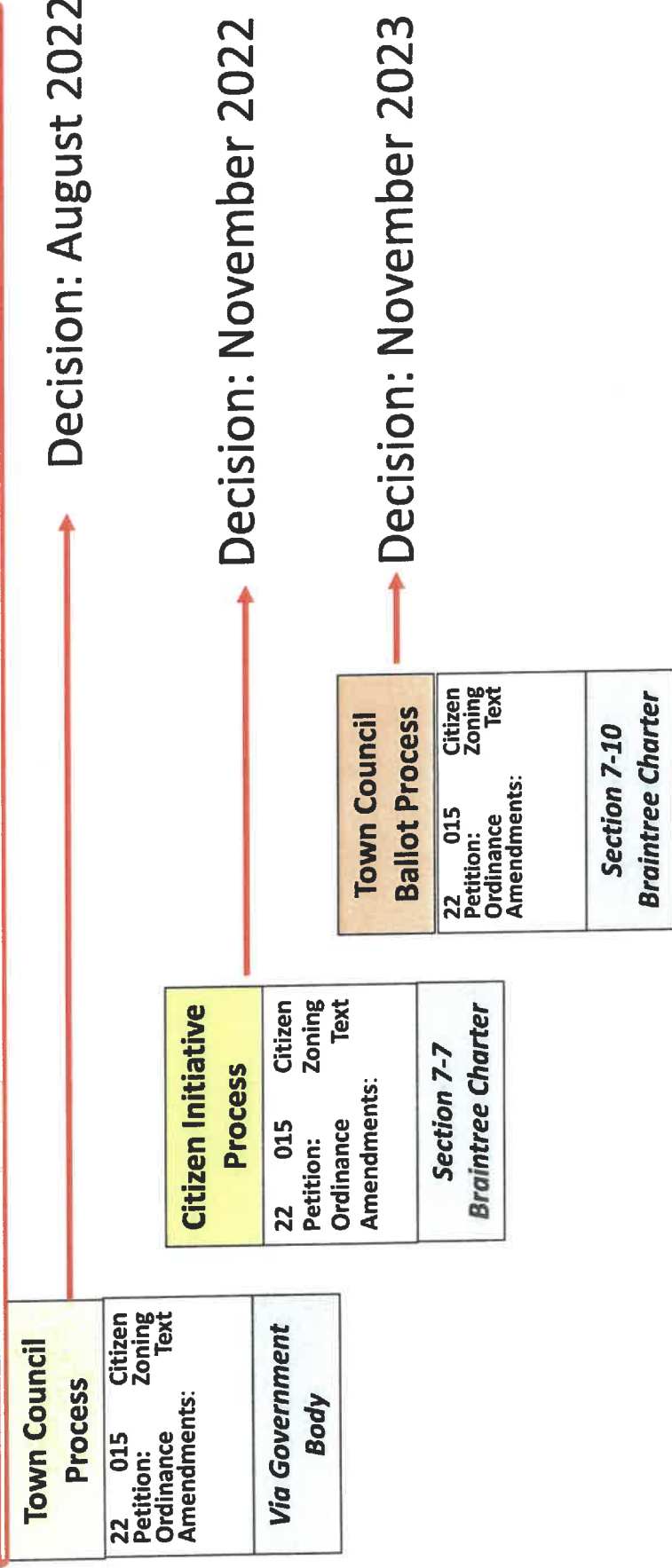
- Submit to voters at **any regular town election** for adoption or rejection any measure in the same manner with the same force and effect as is hereby provided for submission by petitions of voters

Section 7-1 Town elections: general, preliminary

- The **regular town election** shall be held on the first Tuesday following the first Monday in **November in each odd-numbered year**
